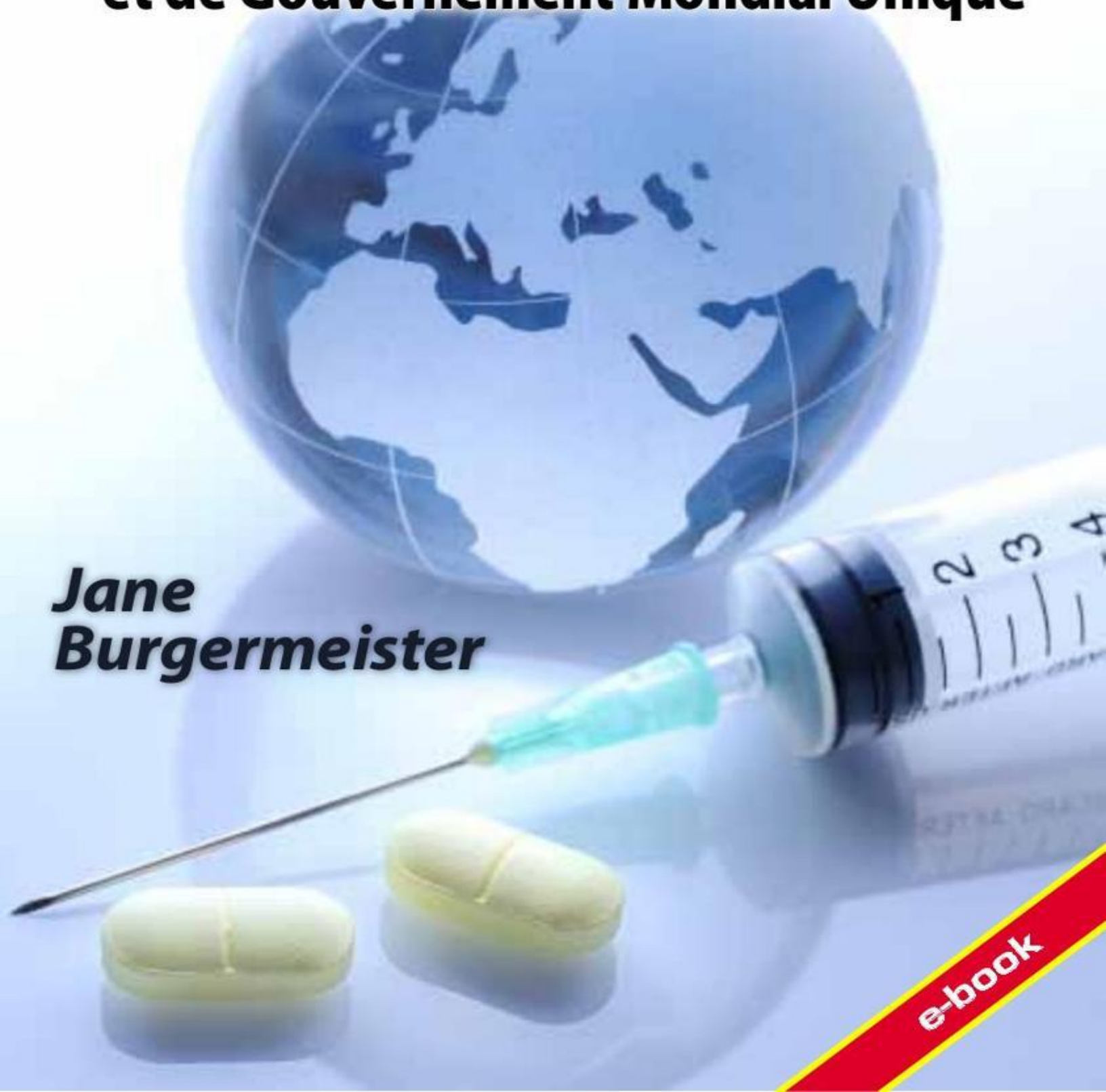

A failed attempt at depopulation and a One World Government

CHAPTER ONE

FAKE PANDEMIC

He was 64. He was born in Mexico City and was considered one of the world's leading experts on Aztec civilization. He was curator of the National Museum and was chosen to offer a guided tour to the newly elected President of the United States, Barack Obama, during his first state visit to Mexico on Friday, April 16, 2009.

His hands sketched gestures in a lively way; His shoes hammered the polished parquet floor. Surrounded by officials, he accompanied Obama and Felipe Calderon, the President of Mexico, to Room 7, the Mexico Hall or "Sala Mexica", where the most famous of all Aztec treasures is kept.

The "Sun Stone", illuminated by a few soft lamps, emerged from the darkness. Weighing 25 tons and 12 feet in diameter, the finely carved basalt stone, mounted high on a monolithic slab, illustrates aspects of Aztec cosmology.

Pointing upwards, archaeologist Felipe Solis explained the Aztec concept of time as a medium that allows things to grow organically, to evolve and develop in their full extent, similar to how a flower or tree requires a certain period of time to grow, in several consecutive stages. from a seed before reaching maturity. More importantly, he also discussed what meaning might be given to December 21, 2012, when the earth will position itself in a rare alignment with the galactic center.

Could this be the beginning of a new era?

Soon after, he felt a sharp pain in his throat and chest.

He thought it was just the ordinary flu, and continued to work on his current project.

He was preparing an exhibition that would be launched the following month, in May, called

: "Teotihuacan, City of the Gods". He wanted to convey all his admiration for what the Aztecs had accomplished, and demonstrate the full glory of their Empire, destroyed by the Spanish invaders, in a unique and innovative presentation with a lot of background information on the ideological and political dimension of the ceremonial sites where ritual sacrifices had taken place, because the Aztec Empire had a brutal side; A large number of human beings were sacrificed to appease the gods.

The next morning, he woke up and told his family he was having trouble breathing.

His lungs were on fire. His condition deteriorated rapidly. That same day, Saturday, he went to the hospital. He was admitted directly to an intensive care unit. His doctors diagnosed him with viral pneumonia, aggravated by diabetes. He fell into a coma, had a slight improvement, but again lost consciousness.

On Thursday, April 23, at 7 a.m., Felipe Solis died. The clinical cause announced was a heart attack, according to a report published in "El Our" under the title: "Serves Obama and dies after 7 days"; "Atiende a Obama y muere a los 7 días."

At that time, Mexico was already on high alert due to a swine flu outbreak that coincided with Obama's visit. Outside the hospital where Solis was in intensive care, soldiers distributed masks in the streets as hysteria gripped the South American capital. On the same day Solis died, Mexico City was quarantined for five days. For five days, 20 million people were forced to stay at home, turning the world's second largest city into a ghost town. Shops, schools and universities were closed; Demonstrations have been banned. Soldiers carrying weapons patrolled the streets.

These draconian measures were implemented while the World Health Organization (WHO), the United Nations' global health watchdog, had confirmed only 9 deaths from swine flu in Mexico at that time.

Although the first victim of the swine flu, a census clerk named Maria Adela Gutierrez, died on April 13, as was later reported, it was news of Felipe Solis' death that was first telegraphed around the world through the media.

On Saturday, April 25, Bloomberg reported that Solis died the same day after meeting Obama, possibly from swine flu, associating from the beginning the origin and trajectory of the pandemic with the person and movements of the president of the United States.

"Obama was received at the Museum of Anthropology of Mexico City by Felipe Solis, a renowned archaeologist, who died the next day of flu-like symptoms," the newspaper "Reforma" reported. "The newspaper did not confirm whether Solis had swine flu or not," writes Bloomberg's Thomas Black.

In fact, without the presence of the international press that accompanied Obama on his visit to Mexico, news of the swine flu would not have reached such a wide audience so quickly.

The speed with which swine flu broke out in the eyes of the world is underscored by the fact that it was nowhere on the media radar screen when Obama and Calderon held a joint press conference on April 16.

Within days, however, swine flu exploded onto the global media scene as a pandemic in its own right, dominating cable television screens, newspaper headlines, and Internet news sites. The mainstream media presented swine flu as a threat on a different scale than all other diseases, as a new killer virus that had become a danger to the entire world in a very short period of time, and since

that day the mainstream media has played a key role, shaping people's perception and attitude towards the swine flu virus.

A five-year-old boy in La Gloria, a remote village of 3,000 people in the Sierra Madre hills, where many farmers still use horse-drawn carts, tested positive for the swine flu virus or A/H1N1 virus, according to a government statement, when a sample was sent to laboratories in the United States and Canada.

Calderon's government said that Edgar Hernández, who recovered quickly, had the disease earlier that month and was probably the cause of the swine flu outbreak.

But while Edgar Hernandez's test tested positive for swine flu, he was the only villager to catch it in La Gloria.

Furthermore, and it is not clear, how could a single little boy living in a remote village where walking, cycling and horseback riding are still the main means of transport, have spread swine flu to so many people in such a short period of time for the whole of Mexico.

– and even the whole world – is potentially threatened in a few days?

The boy's mother, Maria del Carmen Hernández, added to the mystery.

"I don't know where the virus came from, and I don't think anyone else knows either," she said, according to a report in the Financial Times newspaper on the 12th. May 2009.

It was reported that the virus originated from a nearby pig farm. But officials who inspected pigs at the Granjas Carroll plant in Mexico City, 50 percent of which is owned by the U.S. company Smithfield, found that none of the animals had been infected with the swine flu virus.

Yet, according to the WHO and mainstream media accounts, the swine flu virus from this pig farm infected a little boy and spread from a remote village in Mexico to the United States, as well as to Europe and the rest of the world within days. On Wednesday, 29 April 2009, WHO reported cases of swine influenza in 9 countries.

The first death from swine flu in the United States was also reported on April 29: a 23-month-old child in Texas was diagnosed with swine flu by Dr. Richard Besser, acting director of the Center for Disease Control and Prevention (CDC). the U.S. PARTNER OF THE WHO.

As of that date, confirmed cases of swine flu in the United States had already been reported at 66 in 6 states, with 45 cases of swine flu in New York, 11 in California, six in Texas, two in Kansas and one in Indiana and Ohio. New York's health commissioner said hundreds of schoolchildren were suffering at school and confirmed that some students had swine flu.

The press frenzy reached its climax: victims of the pandemic were mentioned on evening news around the world.

"Death flies through the air" ("Der Tod fliegt durch die Luft") was a standard headline in the German newspaper "Die Süddeutsche Zeitung" on April 27.

About 6 weeks later, on 11 June, WHO reported cases in 74 countries, and on 1 July infections were confirmed by WHO in 120 countries.

No matter how quickly the swine flu spread, it killed few people.

By July 7, only 429 people had died from swine flu, according to WHO's own figures. That's a fraction of the 36,000 people who die each year from seasonal flu in the United States alone, according to CDC estimates.

It would not be an exaggeration to say that the swine flu pandemic is purely a media event, as there have been few actual deaths compared to other diseases. Despite this, the networks have saturated the airwaves with video footage, reports and images that suggest the world's population is in imminent danger because of the swine flu virus.

Video footage of people wearing masks waiting in hospital hallways for rare medical therapies, or children on ventilators, have given a degree of visual support to the claim that the world is in the grip of the dangerous swine flu pandemic that has absolutely no basis in fact.

But beginning with the emergence of the swine flu pandemic in late April, the media fashioned and framed a narrative to their liking, presenting the story of an easily transmissible virus raging across Mexico, killing masses of people, which is out of all reality. The sheer amount of video clips and images of alleged pandemic victims, pig farms and soldiers with masks, effectively helped to hide the objective fact that swine flu is mild and has killed very few people, even according to WHO's own figures.

However, the real purpose of the media coverage has not been to provide factual information about the nature of the swine flu virus.

The purpose of the cover was to create fear in the public, to drive them to run to buy the swine flu vaccine.

For from the very moment the swine flu virus burst onto the world media scene like a scoundrel, the swine flu vaccine appeared as a hero and savior in this global drama. This is despite the verifiable and objective fact that the pandemic swine flu vaccine has not been sufficiently tested and contains mercury as well as an adjuvant, squalene, known to cause autoimmune diseases.

The WHO immediately gave instructions for the CDC and pharmaceutical companies to begin preparing to develop a swine flu vaccine.

Shares of Baxter, Novartis, GlaxoSmithKline, Sanofi and CSL, the top five vaccine manufacturers, climbed as they were expected to make billions from pandemic vaccine orders.

Projects were put in place in 2005 to vaccinate billions of people in the event of a pandemic emergency. Most governments around the world, including all governments in Europe as well as the governments of the US, Canada and Australia, had contracts with pharmaceutical companies to supply vaccines against the avian influenza pandemic in 2005. These contracts for pandemic vaccines began to be activated in April 2009.

The U.S. government sealed contracts with Novartis, Sanofi Pasteur, GlaxoSmithKline, CSL, and MedImmune to produce the swine flu vaccine. The France purchased 94 million individual vaccinations from Baxter, Sanofi, GlaxoSmithKline, and Novartis at a cost of €869 million, and Canada placed an order for 50.4 million doses of GlaxoSmithKline at a cost of \$400 million, to name just two examples.

Without wasting time, the WHO ordered on April 24 that its Pandemic Control Room, designed to track the spread of a pandemic around the world and therefore equipped with supercomputers linked to the security forces of UN member states, be staffed 24 hours a day, seven days a week for the first time. As a prelude to the declaration of a level 6 pandemic emergency, the highest level of alert on the planet, a level that triggers the implementation of existing mass vaccination plans by governments around the world.

Grim predictions of an avian flu pandemic that could cause the deaths of millions of people around the world and the collapse of

economic and social infrastructure have been made in recent years, and amplified by mainstream media coverage, despite the fact that there is no scientific basis for these predictions.

In fact, the world came close to an avian flu pandemic in February 2009, just about 10 weeks before the pandemic swine flu outbreak in Mexico. An avian flu pandemic was nearly triggered when the pharmaceutical company Baxter --- headquartered near Chicago in Deerfield, Illinois, where Obama has his Senate seat.

--- contaminated 72 kilos of seasonal influenza vaccine material with live avian influenza virus in his equipment in Orth an der Donau, then distributed this material through a company called "Avir Green Hills Biotechnology" in Vienna to 16 laboratories in Austria, Slovenia, Czech Republic and Germany.

A WHO reference laboratory is supplying the bird flu virus that Baxter used to contaminate vaccine material, according to a Baxter spokesperson quoted in the media.

It's not clear why Baxter had the bird flu virus in its facility in the first place. The avian influenza virus is considered one of the deadliest viruses known to mankind, with a 60% mortality rate. It was genetically modified in U.S. weapons labs from the Spanish flu virus, according to an October 2005 report in Der Spiegel.

The Baxter laboratory itself says that the contamination of the 72 kilos of vaccine material was an accident. However, the company would not comment on the sequence of actions inside its facilities that might have resulted in the accidental contamination of such a large amount of vaccine material or how so much contaminated material could have left its facilities undetected.

Since Baxter is obliged to use Level 3 of the Biosafety Regulations when experimenting with the avian influenza virus, accidental contamination can be virtually ruled out. The standards for

protecting a virus ranked among the world's most dangerous biological weapons are very different from those for working on harmless materials in a standard laboratory. They include the requirement to work in a sealed laboratory environment accessible only using electronic codes, double doors, anterooms and also the need for staff to wear special protective clothing and masks.

The contamination of the vaccine material was discovered only after a technician from the Czech BioTest laboratory injected the material into the ferrets, which became ill and had to be destroyed. Biotest sounded the alarm and emergency pandemic control measures began to be implemented on Friday, February 6, 2009.

As a result, 35 Avir laboratory staff in Austria and BioTest in the Czech Republic, which had come into contact with the contaminated materials, had to be treated preventively against avian influenza in hospital, which highlighted the danger that this material - intended for use in vaccines - posed to exposed people, even in a laboratory environment.

The Times of India reported that Baxter had almost triggered a global bird flu pandemic.

"The mixing of viruses by the laboratory could have led to a pandemic" was a title of March 6, 2009.

This incident in Austria in February 2009 strongly suggests that pharmaceutical companies are actively working to try to trigger the same pandemics they will benefit from, given that they have sealed lucrative contracts in advance to supply pandemic vaccines.

Although the Austrian police opened an investigation after I filed a complaint with the Vienna State Prosecutor's Office on April 8, the investigation was dropped in September 2009, shortly before Baxter had applied for final EU-wide marketing authorization for its swine flu vaccine, CELVAPAN.

The reasons behind the decision to drop the investigation are unclear.

Baxter themselves have said the contamination of vaccine material was an accident. However, the company did not explain exactly what sequence of actions were performed inside its biosafety laboratory that could have resulted in such accidental contamination of 72 kilograms of seasonal influenza vaccine material.

Panasonic and other companies like IBM have made their own internal plans within the company to deal with a pandemic emergency, indicating they may have some insider knowledge.

There are also indications that the swine flu virus was genetically modified in laboratories. Australian virologist Adrian Gibbs published a study in the *Virology Journal* in November 2009 that showed that the swine flu virus was likely the product of three strains from three continents that exchanged genes in a laboratory or vaccine manufacturing plant.

A vaccine against the H1N1 swine flu virus was patented in 2007 by Baxter - and yet the virus was touted as completely new by the WHO. It was the novelty of this virus that was supposed to be the reason why people had no immunity, and therefore the justification for the mass vaccination campaign in the first place.

There was also a swine flu epidemic in 1976, which resulted in a mass vaccination campaign in the United States that had to be abandoned because more people died from the vaccine than from the mild flu.

Nevertheless, in 1994, Laurie Garrett, Senior Fellow for Global Health at the Council on Foreign Relations (CFR), published a book entitled "The Coming Plague", implying that a deadly pandemic was inevitable, without advancing any scientific basis to justify such a

claim. Garrett was also among the first to advocate for a comprehensive WHO-based pandemic response system.

In June 1996, the U.S. Air Force published a study titled "Air Force 2025," describing the emergence of a deadly influenza pandemic in 2009 as a possible "future scenario" in a conflict context.

In 2003, Garrett intensified the rhetoric, warning "doom may loom" with "the emergence of a virus capable of infecting 40 percent of the world's human population and killing an unimaginable number."

"The devastation that such a disease could wreak is commonly compared to the devastation of the Spanish flu of 1918-19, which killed 50 million people in 18 months. But bird flu is much more dangerous. ... humanity may well be facing a pandemic unlike any other we've ever seen," Garrett wrote in a 2003 report titled "The Next Pandemic" for a Council on Foreign Relations (CFR) publication.

In 2005, the United Nations Coordinator for Avian Influenza, David Nabarro, indicated that a flu pandemic could kill between 5-150 million people, and that a pandemic catastrophe could occur at any time, without providing any scientific evidence for such a prediction.

The World Bank estimated in 2008 that a pandemic could kill 71 million people worldwide and plunge the global economy into a "major" global recession, costing more than \$3 trillion.

Governments helped foment fear of a pandemic.

Michael Chertoff, the Secretary of Homeland Security of the United States until January 2009, predicts in an essay published in No. 51 of the quarterly

"Joint Force Quarterly" in 2008, that "a severe flu pandemic could affect the lives of millions of Americans, causing a significant

number of illnesses and deaths, and significantly disrupt our economic and social stability."

In 2005, WHO extended existing regulations for the treatment of infectious diseases - the International Health Regulations - to create a single, unifying strategic concept in how to manage the consequences of a global pandemic involving the synchronization of measures taken by all governments and pharmaceutical companies with those of WHO as soon as WHO has identified a pandemic.

On 7 July, the WHO Strategic Advisory Group of Experts on Immunization (SAGE) held a meeting in Geneva and recommended the implementation of a global immunization programme with new, largely untested pandemic vaccines that would, however, be admitted to the market in the event of a pandemic emergency.

A few days later, on 11 July, WHO Director-General Dr Margaret Chan endorsed the SAGE recommendations, launching the world's largest mass vaccination campaign ever, using the new two-dose vaccines, formulated with oil-in-water adjuvants, as well as mercury-containing thiomersal.

Health workers, firefighters and police, followed by babies, children and pregnant women were identified as the priority groups to be vaccinated when the swine flu vaccination campaign began in autumn 2009, although there are no clinical data on the impact of the new pandemic vaccines on the health of pregnant women and children.

Under special pandemic emergency regulations, the vaccine manufacturers should not provide clinical data demonstrating that their vaccines are safe or effective. The rapid trial process authorized under a pandemic emergency reduced some of the clinical trials to as little as 5 days. In addition, these short and rare trials were limited mainly to healthy adults.

The French government unveiled plans to set up 1100

Special vaccine centers across the country to conduct the largest vaccination campaign in its history. The CDC in the United States announced that 90,000 points of sale of swine flu vaccines would be set up across the United States. Countries such as Germany and the United Kingdom were preparing to implement plans to use football stadiums for the vaccination campaign.

But in January 2010, the ambitious mass vaccination campaign launched by the WHO was reduced to "shreds". The French government aimed to vaccinate 100% of its population by the end of January 2010. But the government was forced to abandon its program in early January due to the refusal of the vast majority of people to receive vaccines and growing protests during the campaign.

Against the expectations of the WHO and national governments, only a small proportion of the population in North America and Europe received the swine flu vaccine, leaving governments sitting on gigantic surplus stocks.

In addition, investigations had begun to determine whether WHO had communicated objectively false content about the danger of a swine flu pandemic and also about the safety of swine flu vaccines.

It is a verifiable and documented fact that WHO, national governments and the mainstream media consistently and systematically exaggerated the dangers of the swine flu virus and the threat of a lethal mutation. It is a verifiable and unambiguous fact that the swine flu pandemic vaccine, on the other hand, was presented as safe, tested and effective, even though there was insufficient clinical data to support these claims. It is a fact that false claims were made about the usefulness of the vaccine for children

and pregnant women, and which were absolutely not based on the results of clinical trials.

In the US, it was the alternative media and radio stations that allowed facts about the swine flu vaccine to spread rapidly. People like Dr. Rebecca Carley, Dr. Robin Falkov, Dr. Joseph Mercola, Dr. Ghislaine Lanctôt and Mike Adams helped spread the information about the dangers of the vaccine that the mainstream media had suppressed. Radio programs such as Project Camelot, Rumor Mill News, and Coast to Coast played a major role in warning the public of the risks of the new vaccine as well as laws allowing forced vaccination and quarantine.

In Europe, where alternative media are less developed and there are far fewer independent radio stations, information circulated through blog reports such as "Alles Schall und Rauch" in Switzerland.

In France, information about the vaccine galvanized the Internet. Christian Cotten, a French activist, said he had never seen so much Internet activity in his entire life as he had in the previous seven months when people were discussing the benefits of getting the swine flu vaccine online. Raymond Haugustine in Belgium, Vicky Chrysou in Greece, Claire Knox in Scotland, Joanna Karpasea-Jones in England, Jagoda Savic in Bosnia, Marek Podlecki in Poland, Jean-Jacques Crèvecoeur in Canada, Dr. Marc Girard, Dr. Marc Vercoutere and Danka Derifaj were among the people who devoted time and energy to putting the information into circulation.

In Spain, the video of a nun, Teresa Forcades, helped spread the word along with Claudia Calvo's translations. Penny Bright, Jon Eisen, the publisher of "Uncensored" and filmmaker Brian Dodd helped spread the word in New Zealand.

It was mainly individual citizens who used the Internet that allowed unfiltered information about the swine flu vaccine to circulate in Europe. Facts about the swine flu vaccine that had been covered up by WHO, governments and pharmaceutical companies were disseminated via email, clips on YouTube and Facebook, and independent news sites.

Bloggers kept for public information issues such as the danger of the antiviral drug "Tamiflu" as well as squalene, the adjuvant, while this information was constantly obscured by the mainstream media.

The news that hundreds of people, including nurses in Sweden - the first country in Europe to implement the mass vaccination programme against swine flu - had become seriously ill or even died shortly after receiving the GlaxoSmithKline Pandemrix vaccine in October, was quickly released.

The same was true of the news that the German military had refused Baxter's CELVAPAN vaccine in September after its doctors issued a recommendation against requiring Baxter to drop squalene in order to find a market.

What was crucial was that Polish Health Minister Ewa Kopacz, a family doctor, refused to buy the swine flu vaccines at the end of October because the vaccines had not been sufficiently tested, news that quickly spread around the world thanks to the Internet.

Objective facts about the potential dangers of the swine flu vaccine were also presented by sections of the mainstream media, such as France 24 for example, which gave a platform to Dr. Marc Girard, which contributed to the erosion of support for swine flu vaccination.

At the end of January 2010, only about 30 million people in Europe, including 218,000 pregnant women, were vaccinated against swine flu despite the unprecedented campaign of scaremongering by

WHO, governments and the media about the threat of swine flu. According to a CDC estimate, 61 million Americans were vaccinated against swine flu or about 20% of the U.S. population. In the United States, too, the overwhelming majority of people rejected vaccines.

In a speech to WHO's Executive Board on 18 January, Director-General Dr Margaret Chan said the organization had not planned for people to refuse to receive the swine flu vaccine. She attributed this refusal to the growth of new communication and information technologies, which had indeed allowed people to access information, documents and facts about the swine flu vaccine that had been obscured by WHO and pharmaceutical companies as well as by the mainstream media.

The Internet has also proven to be a powerful and even revolutionary tool, gaining support from critical investigations into the swine flu "scam". On 26 January, the Parliamentary Assembly of the Council of Europe (PACE) held an emergency public hearing to determine whether the WHO had exaggerated the danger of the swine flu pandemic in order to force governments to buy vaccines and thus enrich pharmaceutical companies.

Former member of the SPD (Social Democratic Party) of the German "Bundestag" (Parliamentary Assembly) and chairman of the health committee at PACE, Dr.

Wolfgang Wodarg, who is an epidemiologist and lung specialist, presented the resolution of an investigation into what he called one of the "greatest medical scandals of the century".

The text of Wodarg's motion noted: "In order to promote their patented influenza drugs and vaccines, pharmaceutical companies have influenced scientists and official bodies responsible for public health standards to alarm governments around the world and make them waste the resources of their already tight health budgets on

ineffective vaccination strategies and have needlessly exposed millions of healthy people. at the risk of an unknown amount of side effects from inadequately tested vaccines. The 2005-2006 avian flu campaign combined with the 2009-2010 swine flu campaign appear to have caused a great deal of damage not only to some vaccinated patients and to public health budgets, but also to the credibility and accountability of important international health agencies. "

WHO's Special Advisor on Pandemic Influenza, Dr. Keiji Fukuda, accompanied by a representative of European vaccine manufacturers, Sanofi senior executive, Dr. Luc Hessel, faced harsh criticism at the public hearing, but denied accusations of hype around swine flu to make money.

"The world is going through a real pandemic. The description of it as a fake pandemic is erroneous and irresponsible. We welcome any legitimate review process that can improve our work," Mr. Fukuda after the hearing.

But many WHO experts who had claimed to be independent turned out to have financial ties to the same pharmaceutical companies that benefited most from their recommendations.

Danish journalist Louise Voller reported members of Group SAGE with financial ties to pharmaceutical companies. These include Professor Juhani Eskola, director of the Finnish Vaccine Research Programme (THL) whose institute received nearly €6.3 million from GSK (GlaxoSmithKline) for vaccine research in 2009, according to documents acquired through the Danish Freedom of Information Act, indicating that GSK is the institute's main source of funding.

It is on the recommendation of the Finnish National Institute of Health, "THL" (Terveyden ja hyvinvoinnin laitos), and SAGE that the Finnish government bought millions of doses of GSK's Pandemrix vaccine.

Eskola did not disclose his conflict of interest, as was the case with other WHO vaccine specialists. Dr Neil Ferguson received funding from Baxter, GlaxoSmithKline and Roche as well as the insurance companies he advised on pandemics, but this was revealed by the WHO only after the Danish newspaper reported the facts. Dr. Friedrich Hayden, a consultant for MedImmune and Sanofi Pasteur, also received money from Roche, RW Johnson and SmithKline Beecham. These interests were not declared on the WHO website.

Other WHO experts have links to vaccine manufacturers, including Professor Malik Peiris of the University of Hong Kong, who has received money from Baxter, GSK and Sanofi Pasteur. Dr. Peter Figueroa, a professor at the University of the West Indies, received money from Merck. Dr. Arnold Monto is an advisor to Chiron, GlaxoSmithKline, MedImmune, Roche, Novartis, Baxter and Sanofi Pasteur. Dr Albert Osterhaus, head of the European Scientists Fighting Influenza, is funded by Baxter, Crucell, Novartis, Hoffmann-La Roche, MedImmune, Nobilon, Sanofi Pasteur MSD, Glaxo SmithKline and Solvay.

In addition, dozens of directors from pharmaceutical companies attended the July 7 SAGE meeting that recommended a global vaccination campaign with pandemic vaccines, but with the official status of "observers." It is unclear what role these pharmaceutical executives from companies like Novartis and Baxter played in creating SAGE's decision to recommend the vaccines because the WHO refused to release the minutes, saying no minutes were written.

This lack of transparency has raised concerns that pharmaceutical companies have played a key role behind the scenes at WHO, also in order to obtain the modification of the pandemic criteria, which was crucial, to allow the declaration of a level 6 emergency pandemic vis-à-vis mild swine flu.

In fact, in order to be fully able to declare a pandemic emergency, the WHO had to change the criteria. The WHO changed its definition of a pandemic on its website at the end of May 2009, abandoning the need for "a considerable number of people to have contracted disease or death."

for a pandemic to be declared. Instead, a virus that spread to two WHO areas was deemed sufficient.

The change in criteria allowed for a level 6 pandemic declaration that was finally carried out by WHO on June 11 on the recommendation of an emergency committee whose names the WHO refused to disclose so that no assessment of their links to pharmaceutical companies or conflicts of interest would be possible.

The WHO defended itself by saying that it had not changed the pandemic criteria, but had simply reverted to the original definition, which was more flexible.

By definition, however, a pandemic is a one-time event qualitatively different from a seasonal influenza infection.

To define a flu pandemic by including every type of flu, even one as mild as swine flu, is to distort the very meaning of the word.

"pandemic" beyond recognition.

The WHO's new definition of pandemic is so vague that it could apply to any influenza, totally undermining the rationale for a global pandemic emergency management system.

Fukuda told the Council of Europe public hearing that the WHO definition of pandemic was the result of the work of 135 experts. If this is the case, WHO must be held accountable for hiring, and listening, these experts who are also incompetent.

"Rational, scientific and independent advice should be the top priority, but there was an imperative behind this which was financial," British MP Paul Flynn told the Council of Europe hearing.

On July 10, adding to the impression that the WHO was manipulating data to justify declaring a pandemic, the organization stopped recording cases of swine flu infection and told governments that they should stop testing to see if people had swine flu.

While there was no evidence that the flu virus would mutate into a deadly virus, the WHO maintained that this was a likely scenario.

A deadly virus is only likely to emerge, in reality, if a scientist with close ties to the WHO, Professor Bruno Lina, succeeds in mixing swine flu with the bird flu virus in a laboratory in Lyon, as reported in the scientific journal Nature.

Concerns about the influence that pharmaceutical organizations have on WHO are reinforced by the fact that 81% of the organization's budget for 2008-2009 comes from voluntary contributions, according to an estimate of the budget on the CFR (Council on Foreign Relations) website. WHO member states have given just \$958 million while three times as much – \$3.2 billion – comes from voluntary donations from the private sector, national governments, NGOs and private foundations, such as the Rockefeller Foundation.

Because WHO has not responded to my requests for access to its annual budget accounts at the time of writing, it is not possible to see which pharmaceutical companies contribute to WHO using which channels. Pharmaceutical industry associations are classified as NGOs in the WHO budget.

From funding alone, it can be seen that behind the WHO stand powerful pharmaceutical companies, and, ultimately, banks, and these entities are also the main beneficiaries of any declaration of

emergency against a swine flu pandemic as well as any mass vaccination campaign.

Fukuda and Hessel's public hearing at the Council of Europe was just one of many investigations into whether the WHO had exaggerated the threat of the swine flu virus in order to enrich pharmaceutical companies. In France, a parliamentary inquiry into the government's handling of the swine flu vaccination campaign was announced in January.

In 2009, the Dutch parliament investigated the conflicts of interest of WHO expert and advisor to the Dutch government, Albert Osterhaus. Osterhaus was also chairman of the European Scientific Working Group on Influenza, which is fully funded by Baxter, Novartis, GlaxoSmithKline, MedImmune, Roche and other pharmaceutical companies that are declaring billions of pandemic emergencies.

Many scientists advising national governments have been found to have links to vaccine manufacturers. Sir Roy Anderson, UK government swine adviser and SAGE Group member, sits on GSK's board, for example.

The European Medicines Agency, the EU's vaccine regulator, is two-thirds funded by pharmaceutical companies.

As serious as the allegations that pharmaceutical companies sought to profit from a fake pandemic are, there is strong evidence to support the idea that the mass vaccination campaign was an attempt to cause damage and death to millions.

If swine flu vaccines had only been designed for profit or as part of a patent scam, pharmaceutical companies could have inserted some harmless substance like sugar water.

But swine flu vaccines contain mercury, which is known to cause neurological damage and autism in children. In addition, they contain adjuvants, including squalene. There is a large body of scientific evidence that squalene contributed to Gulf War syndrome among American and British veterans.

Both vaccines are classified as biodefense stockpile drugs by the European Union and U.S. regulators based on Biopharma databases. They are, therefore, biological weapons. This classification by government regulators is the reason why swine flu vaccines from GSK and Novartis were stored in military barracks in countries like France and Switzerland before being distributed to vaccine centers.

A UN employee based in Switzerland was summoned to a military base to receive his swine flu vaccine.

These vaccines cannot be given to people under ordinary circumstances, because clinical trials proving that they are safe have not been conducted.

However, as soon as WHO declares a level 6 pandemic, new standards for vaccines and anti-viral drugs come into effect.

Antiviral drugs such as Tamiflu, which is associated with serious side effects, were allowed to be used months after their expiration date.

According to the special procedures for emergency pandemic approval, pandemic vaccines do not have to be proven to be safe or effective before they are administered to the population.

Vaccine manufacturers are only required to conduct a study to check if the vaccines have serious side effects after the vaccines have been administered.

GSK is currently conducting a study on the swine flu vaccine

"PANDREMIX" in the UK.

Governments are not required to conduct any studies to determine whether vaccines have any adverse side effects.

Polish Health Minister and family doctor Ewa Kopacz rejected the swine flu vaccines for Poland precisely because they were not adequately tested.

Both GSK and Novartis' swine flu vaccines contain squalene, which can lead to an autoimmune disease. In addition, Baxter's "CELVAPAN" was made using the diseased kidneys of African green monkeys, the cell culture that gave the world AIDS.

"FOCETRIA," Novartis' swine flu vaccine, contains MF59, an adjuvant containing squalene and polysorbate 80, two ingredients that have been linked to disease.

GSK Pandemrix contains squalene fAS03 as well as polysorbate 80.

These ambiguous biological weapons/vaccines could be granted to civilian populations only because a declaration of pandemic emergency by the WHO triggers new standards for vaccine approval in the EU. The safety and efficacy of vaccines no longer need to be proven under European Medicines Evaluation Agency (EMA) guidelines under the pretext of the urgency of managing a deadly pandemic.

It is true that squalene is an oil molecule that is found naturally in the human body, but administered intravenously, it prompts the immune system to destroy all the natural squalene in the body, including squalene that had been injected into the bloodstream.

Dr. Joseph Mercola explains:

"Oil-based vaccine adjuvants like squalene have been shown to produce relentlessly concentrated immune responses over long periods of time."

A 2000 study published in the "American Journal of Pathology" demonstrated that a single injection of the adjuvant squalene administered to rats triggered "chronic immune-mediated, joint-specific inflammation, also known as rheumatoid arthritis."

Your immune system recognizes squalene as an oil molecule that originated in your body. It is found everywhere in your nervous system and brain. In fact, you can consume squalene in olive oil and not only will your immune system recognize it, but you will also be able to enjoy the benefits of its antioxidant properties.

The difference between "good" and "bad" squalene is the route by which it enters your body. The injection is an abnormal entry route that prompts the immune system to attack all of your body's squalene, not just the vaccine adjuvant.

Your immune system will try to destroy the molecule wherever it finds it, including in places where it occurs naturally, and where it is vital to the health of your nervous system.

Gulf War veterans with Gulf War Syndrome (GWS) received squalene-containing anthrax vaccines. The MF59 (Novartis' squalene adjuvant) was an unauthorized ingredient in experimental anthrax vaccines and has since been linked to devastating autoimmune diseases suffered by countless Gulf War veterans.

The Ministry of Defence has gone out of its way to deny that squalene was indeed a contaminant added to the anthrax vaccine administered to deployed and undeployed military personnel of the Persian Gulf War as well as to participants in the more recent Anthrax Vaccine Immunization Program (AVIP).

However, the U.S. Food and Drug Administration (FDA) has discovered the presence of squalene in some batches of AVIP products. A test was developed to detect anti-squalene antibodies in GWS patients, and a clear link was established between the contaminated product and all GWS patients who had been vaccinated with a squalene-containing vaccine.

A study conducted at Tulane Medical School and published in the February 2000 issue of "Experimental Molecular Pathology" includes these astonishing statistics:

"... the vast majority (95%) of deployed patients with declared GWS disease had antibodies to squalene. All (100%) GWS patients vaccinated for the Desert Storm/Desert Shield service who did not deploy, but who had the same signs and symptoms as those who deployed, had antibodies to squalene.

In contrast, none (0%) of deployed Persian Gulf Veterans who did not have the signs and symptoms of GWS had antibodies to squalene. Neither patients with idiopathic autoimmune disease nor healthy controls had detectable serum squalene antibodies. The majority of symptomatic GWS patients had serum antibodies to squalene. "

According to Dr. Viera Scheibner, Ph.D., former Principal Investigator for the Government of Australia:

«... This adjuvant [squalene] contributed to the reaction cascade called "Gulf War syndrome", in soldiers involved in the Gulf War.

The symptoms they have developed include arthritis, fibromyalgia, lymphadenopathy, rashes, photosensitive rashes, malar rashes (butterfly rashes), chronic fatigue, chronic headaches, abnormal body hair loss, non-healing of skin lesions, canker sores, dizziness, weakness, memory loss, convulsions, mood changes, neuro-psychiatric problems, anti-thyroid effects, anemia, elevated ESR (sedimentation rate or ESR), systemic lupus erythematosus,

multiple sclerosis, ALS (amyotrophic lateral sclerosis), Raynaud's phenomenon, Sjörger's syndrome, chronic diarrhea, night sweats and febrile (mild fevers). "

A study of 39,000 Germans who received a FLUAD vaccine with squalene in 2000 did little to clarify the long-term consequences of squalene because no follow-up studies were conducted to determine whether the subjects developed autoimmune diseases over a longer period of time.

"It often takes years to diagnose autoimmune diseases like those seen in Gulf War syndrome because of the imprecision of early symptoms. Complaints like headaches, fatigue and chronic pain are symptoms of many different diseases and pathologies," notes Dr. Mercola.

Dr. Jürgen Seefeldt calculated that 850,000 people would have died from the swine flu vaccine in 15 years if the German government had given it to the 50 million people, as planned. He based his estimates on the number of young, healthy American soldiers who died of cancer and autoimmune diseases 15 years after receiving squalene-containing anthrax vaccines during the Gulf War.

In 1991, a total of 696,841 U.S. soldiers received anthrax vaccines containing squalene and mercury. By 2005, 11,620 of these soldiers had died, many of them from autoimmune diseases and cancer.

256,000 soldiers demanded compensation and 196,000 of them received damages. Only 29,000 applications were rejected, 31,000 are still under consideration.

Based on the scale of these figures, it can be estimated that about 20 million Germans would have suffered serious side effects as a result of the bite.

Seefeldt called it "the greatest crime since the Holocaust" and called for the resignation of the health minister and German Chancellor Angela Merkel.

However, his calculations of how many people have been harmed by swine flu vaccines may be underestimated.

Much higher concentrations of squalene are present in swine flu vaccines than in anthrax vaccines, and they may be proportionally more harmful.

Gary Jacobucci wrote:

"The average amount of squalene injected into U.S. soldiers abroad and at home in the anthrax vaccine during and after the Gulf War was 34.2 micrograms per billion micrograms of water. According to one study, it was the cause of Gulf War syndrome in 25 percent of the 697,000 U.S. military personnel at home and abroad. You can find this table of FDA analyses from Gulf War batches on the website: "The Military Vaccine Resource Directory" has.. AVA 020 - 11 ppb squalene (parts per billion) b.. AVA 030 - 10 ppb squalene

v.. AVA 038 - 27 ppb squalene

These values were confirmed by Professor R. F. Garry before the US House of Representatives. Prof. Garry was the man who discovered the links between Gulf War syndrome and squalene.

According to his findings, Gulf War syndrome was caused by squalene, the use of which was banned at the Pentagon by a Federal Court judge in 2004.

"As seen on page 6 of this EMEA document, the Pandemrix vaccine contains 10.68 mg squalene per 0.5 ml. This corresponds to 2.136.0000. micrograms per billion micrograms of water, a million times more squalene per dose than in the anthrax vaccine. There is every reason to believe that this will make people sick to a much greater degree than in 1990/91. That seems very murderous to me."

In addition, the Pandemrix vaccine contains particles that are dwarfed in size, but data on the safety of nanovaccines are scarce.

However, in August, a study published in the "European Respiratory Journal" showed that seven young Chinese women suffered permanent lung damage and two died after working for months without adequate protection in a paint factory that used nano particles.

"These cases raise concerns that long-term exposure to nanoparticles without protective measures may be linked to serious damage to human lungs," Yuguo Song, of the occupational diseases and clinical toxicology department at Beijing's Chaoyang Hospital, told Reuters.

But squalene isn't the only toxic ingredient.

"Mercury, which accounts for 49.6% of thiomersal, is an extremely toxic substance that causes cancer," says Dr. Seefeldt.

"Mercury is the most toxic non-radioactive element on Earth and it is toxic even in small quantities."

The Pandemrix vaccine contains 5 micrograms of thiomersal. Two doses -

Two doses were initially planned – would have resulted in people receiving 10 micrograms of thiomersal.

The thimerosal-containing measles-mumps-rubella (MMR) vaccine is believed to have contributed to the huge rise in autism among children in the United States.

Despite the fact that there was no clinical data on how these new swine flu vaccines containing mercury and squalene would affect the health of young children and pregnant women, these groups were identified as priorities by WHO.

Assurances about the safety of the vaccine were given with reference to regulatory approval by the European Medicines Agency and other authorities - but not in reference to clinical data, as there is no clinical data.

In fact, the few clinical studies carried out by pharmaceutical companies on the health consequences of the swine flu vaccine on pregnant women and children began at the same time as the actual vaccination campaign against swine flu and these studies are not conclusive for a year, at the latest. in the fall of 2010.

The massive vaccination campaign against swine flu is, indeed, a gigantic biological experiment, even if such experiments are prohibited by law.

In addition, the results of this experiment will never be fully known, because there is no real pharmacovigilance system in place.

Angelika Kögel-Schauz from "For Parent Information on Vaccines" ("für Eltern Impfaufklärung") described the Paul Ehrlich Institute's manipulation of data on vaccine side effects as an apparent violation of the law.

In addition, authorities make no effort to investigate how many people vaccinated with the swine flu vaccine contracted swine flu from the vaccination itself, as happened on one case in Israel. There

is evidence that the Spanish flu of 1918 was caused by the mass vaccination of soldiers.

In addition, declaring a Level 6 pandemic emergency allowed governments to grant global immunity from lawsuit to pharmaceutical companies in the event that their vaccines cause harm or death.

Given the many other safe, tested and inexpensive ways to protect people from infection with the virus – masks, colloidal silver, vitamins – the decision to implement a mass vaccination campaign using these untested and toxic vaccines is all the more incomprehensible if the WHO really puts people's health first.

Given the damage that the swine flu vaccine can cause, the 2005 International Health Regulations, signed by 193 states, allowing forced vaccination and quarantine in the event of a pandemic is particularly worrying.

Laws authorizing forced vaccination and quarantines were incorporated into the pandemic plans of each national government in 2005, and these plans began to be activated from April 2009.

A document was leaked in August revealing plans by French Health Minister Roselyne Bachelot to vaccinate 100% of the French population by the end of January 2010. The documents contained instructions for the establishment of special vaccine centres: there were plans to incorporate security features into some of these centres, and family doctors would be specifically excluded from the swine flu vaccination campaign.

Earlier this year, Bachelot asked a group of legal experts whether it would be a violation of the law to make vaccination compulsory, and was told that forcing people to receive a pandemic vaccine would be in accordance with the law.

Certainly, as "Humanity" pointed out in a report in January, a plan as ambitious as Bachelot's to vaccinate everyone in France could not expect people to receive the vaccine of their own free will, since they are generally reluctant to get vaccinated. And the decision to set up special vaccination centers against swine flu, integrating secure structures, indicates that the government The French were indeed considering using force when enough people harassed by a fear campaign had already received the vaccine of their so-called "willingness", because a forced vaccination of 100% of the population is logistically impossible.

Nurses and doctors were constrained by "requisition" laws to work in vaccination centres, often in unhygienic conditions and without pay.

In December, Bachelot announced that the government was considering moving the country to the highest internal pandemic level, which would have allowed for the implementation of martial law on a large scale.

A document leaked to Libération in September showed that the government planned to use the swine flu pandemic to suppress civil liberties. The plan envisaged extending the period during which suspects could be detained, without charge and without a hearing before a judge, to a maximum of six months, as well as the holding of secret trials and trials against children in adult courts.

On October 23, Obama declared swine flu a national emergency by bringing the United States to the brink of martial law, when at that time there were only about 1,000 deaths attributable to swine flu.

President George Bush passed Presidential Directive 51

National Security Presidential Directive-51 and Homeland Security Presidential Directives, allowing the use of a catastrophic health

emergency such as a pandemic as a pretext for declaring martial law.

In the United States, provisions on forced vaccination had been incorporated into federal and state laws.

Massachusetts is an example of a state that had passed particularly draconian laws for the event of a pandemic, allowing police to force their way into homes to vaccinate people.

A November UK parliamentary briefing note argued that forced vaccinations would be possible in the UK in the event of a pandemic.

Following the declaration of a Level 6 pandemic emergency, special and secret crisis committees were created in countries around the world.

The latter operate under the authority of WHO. This gives WHO unprecedented powers over national governments, their health services and the military, and also the power to use them to implement a mass vaccination campaign that could cause death and injury to millions.

All these facts taken together are proof that WHO, national governments and pharmaceutical companies have acted in concert to institute an artificial pandemic crisis to implement a mass vaccination program with a toxic vaccine with the aim of deliberately harming and killing large numbers of people.

In parallel, the WHO has taken control of the main functions of governments around the world in what is effectively a global coup, forming the embryo of a new world government. Just recently, many of the heads of government who have supported the swine flu vaccination program, such as German Chancellor Angela Merkel and French President Nicolas Sarkozy, as well as British Prime Minister Gordon Brown, spoke openly in the media about a

"New World Order", and the need for a new world government.

The establishment of a world government can only take place if the sovereign national states are dissolved and such a plan could include the death of a significant number of people, who would resist the transition to a single totalitarian-style world government if that was what was proposed.

The destruction of the lives and health of millions of people could be accomplished by a mass vaccination program with a toxic vaccine.

Certainly, the idea that our governments might actively plan to cause death and damage and plunge their own states into chaos is difficult to grasp.

It is true that few people in Europe or North America today believe that governments represent their interests. Corruption has become all too obvious. This is particularly the case in the USA and the UK. Scandals surrounding the government's manipulation of information to justify the invasion of Iraq and Afghanistan, including the events of September 11, 2001, have eroded trust.

Nevertheless, most people are still convinced that their government adheres to the fundamental rule of law and is governed by democratic institutions that can be held accountable to their electorate.

Moreover, national and international governments are limited in their actions by the rule of law. They certainly cannot mandate vaccines that are known to be dangerous and insufficiently tested.

And yet, this is precisely what happened with the swine flu vaccination campaign in 2009.

It is very difficult for us to believe that our governments want to kill us. Yet the facts of the swine flu campaign indicate that the mass

vaccination campaign with a toxic substance, or possibly by means of the use of force, constitutes an attempted murder on a gigantic scale.

These facts strongly suggest the notion that WHO and national governments deliberately and knowingly implemented a fake pandemic with a state of emergency and mass vaccination campaign not only for financial gain but to achieve significant political gains, namely the founding of One World Government.

That some of the "elites" who wield influence over national and international governments because of their wealth, desire a substantial reduction in the world's population has been well documented.

Ted Turner, the largest landowner in the United States, owner of CNN and a donor to the United Nations, said in an interview with Charlie Rose of PBS that the world's population must be reduced in order to preserve the environment. Turner said that a total population of 250-300 million is optimal, but that implies a reduction of about 95%.

David Rockefeller, who donated the land for the UN building in New York, also argues that the world's population must be reduced.

On March 22, 2009, Jonathan Porrit, Gordon Brown's Green adviser, said that the British population "must go down to 30 million", according to a report published in the Times, but without explaining how this target should be achieved.

Prince Philip went even further in October, implying that the UK would need to reduce its population to 3 million, according to a report published by Agence France Presse.

But do these people really have relationships? Are they really systematically pursuing the goal of population reduction and One

World Government, with the help of the UN and WHO as vehicles of power?

Many people have issued warnings about the existence of a global conspiracy of powerful bankers and royal families that control the world's financial structures and energy industries.

In 1961, John F. Kennedy warned of the existence of a monolithic and ruthless conspiracy in a speech to the American Newspaper Publishers Association.

"We are facing, all over the world, a monolithic and ruthless conspiracy. Which relies mainly on clandestine means to expand its sphere of influence. On infiltration instead of invasion. On subversion, instead of elections. On intimidation instead of free choice, on guerrillas at night instead of armies in broad daylight. It is a system that has enlisted enormous human and material resources in the construction of a tightly knit and remarkably efficient machine that combines military, diplomacy, intelligence, economic, scientific and political operations. His preparations are hidden, not published. His mistakes are buried, and don't make the headlines. His detractors are silenced, not glorified. No expenses are questioned, no rumours are printed, no secrets are revealed," he said.

Meanwhile, even the mainstream media is beginning to recognize that there is a problem.

"The idea that secret banking cabals control the country and the global economy is a given among conspiracy theorists, who stockpile ammunition, bottled water and peanut butter. After the U.S. congressional hearing this week on the American International Group Inc bailout, you have to wonder if these people are really crazy, after all," Bloomberg's David Reilly wrote in January.

"Wednesday's hearing described a secret group deploying billions of dollars to favored banks, operating with little oversight by the public or elected officials," he said.

The same could be said about the swine flu scam.

The Council of Europe's public hearing on Tuesday 26 January described a secret group that deploys billions of dollars to WHO-favoured pharmaceutical companies while operating with little oversight by the public or elected officials.

This global conspiracy or shadow government functions as a state whose imperial ambitions must be realized by the UN and WHO.

It cannot be identified with a nation and it does not have a national army.

Its only armies are the many people who work for it in the various national and international governments and in the secret services to advance the agenda of the shadow government, behind closed doors.

These agents have infiltrated the high offices where they govern laws or guide nations in the direction desired by the shadow government.

These agents obtained their political office in the first place only because they belong to this secret network and they abuse their office to push through the agenda of their funders. They coordinate their activities internationally to support and advance an agenda of world government and mass killing through toxic vaccines, famine and artificially provoked wars and conflicts.

This organization meets to discuss its plans in secret forums, such as the Bilderberg Forum and the World Economic Forum.

Among those present at last year's Bilderberg forum in Greece, in May, were David Rockefeller, Daniel Vassela, CEO of Novartis (manufacturer of the swine flu vaccine), the head of the Austrian government, Chancellor Werner Faymann (the Baxter contamination incident) as well as the Swedish Foreign Minister, Carl Bildt, who gave a lecture on the transformation of the WHO into a body of global competence in health.

The swine flu scam should be understood as part of this overall picture. The swine flu pandemic coincided with a series of financial and economic crises that spread from Wall Street to Europe, Asia and the rest of the world. Today we are facing a major economic depression comparable to the 30s.

But there is evidence that this same group designed the current financial crash to their advantage. The crash is designed to concentrate even more of the world's wealth in their hands when it is over, thanks to their control of governments. The financial crisis was the result of the banks contracting credit under the pretext of being less willing to lend because they had made so many bad debts. Governments have signed agreements pledging taxpayers' money to banks in the event of a default, guaranteeing them a huge profit if they precipitate a crash.

The mainstream media has helped to conceal the fact that bad loans were invented by banks and maintained through the banking system, simply as a pretext for banks to declare themselves highly indebted, stop lending, withdraw money from the economy and plunge nations into economic crisis and debt. a repeat of the events that led to the Great Depression of the 1930s.

As a result of the activities of this group, an enormous number of people are impoverished. The oligarchs who have enriched themselves at the expense of citizens must manage those same citizens frustrated by corruption, unemployment and exclusion.

The growth of the Tea Party protest movement and the demonstrations at the G20 summit in Pittsburgh testify to growing dissatisfaction with economic and social conditions.

But the global "elite" had predicted that social unrest would increase dramatically due to their financial scams.

Parallel to this process of transferring wealth into their hands, this group has set up the structures of an authoritarian world government.

The vehicle of this world government is the United Nations system, including the WHO and the IMF (International Monetary Fund). The stepping stones to world government are the EU and the North American Union. Indeed, the EU was transformed into a semi-dictatorship under the Lisbon Treaty.

The mass vaccination program against swine flu was planned to take place at the same time as the economic crash.

Catherine Austin Fitts, a former U.S. government adviser, said the goal of the swine flu vaccine is population reduction.

"I believe that one of the goals of the swine flu vaccine is depopulation. Maybe that's the goal of the swine flu outbreak too, whether it's through biological warfare or hyping around a flu season," she says on her blog in July.

The same group behind the financial crisis and the swine flu scam also appears to be implicated in the climate change scandal.

Leaks in the form of intercepted emails from the University of East Anglia show how scientists have manipulated data to hide the fact that the current rise in global temperatures is nothing extraordinary when compared to the temperature fluctuations experienced on the planet over the past million years.

Data as well as the peer-review system for publications have been manipulated by scientists such as Phil Jones to suggest that the current temperature increase should be attributed to human carbon emissions.

This falsified data has been used by the UN panel on climate change to justify the introduction of new taxes on carbon emissions as well as the creation of a global bureaucracy to control the amount of energy used in the world.

But the Copenhagen Treaty, aimed at establishing the UN as the economic government of the planet under the pretext of the need to regulate carbon emissions, was rejected at a summit in December, largely due to leaked emails.

Just as in the case of the fake swine flu pandemic, science has been downgraded to the level of fiction to justify the creation of a One Global bureaucracy, with its own military, police forces, and possibly its own world currencies.

Even if the WHO has managed to convey the image of an altruistic organization in the service of human health, there is growing evidence that it is a major player and focal point of a secret biological warfare waged against the peoples of the world by the "elite".

WHO has redefined health promotion as the control of infectious diseases through the use of vaccines. In this way, WHO has created a huge market for vaccines in developing countries.

The global pandemic plan has simply expanded the method used to justify mass vaccination programs in developing countries by applying it on a larger scale, worldwide.

First, the WHO declares that there is an infectious disease, then the WHO states that it can be fought only with vaccines, then the WHO

arranges for the administration of vaccines, if necessary by force.

A recent study from Johns Hopkins University showed that children in Africa are more likely to survive outside of UNICEF programs that include vaccines.

The exact extent of the hold that this international organized crime network holds over the national government was revealed by the fact that only one health minister in Europe, the Polish Minister of Health, refused to order the swine flu vaccine, on the grounds that it posed a risk to people that exceeded the risk of the mild virus.

All health ministers should have reached this decision if they had been guided solely by the facts.

The reason this secret group has been able to advance their agenda is because they control the mainstream media. Today's mass media must be understood as part of a gigantic operation of deception. The mainstream media is in the hands of very few people and the media operate as a cartel with a centralized information strategy. As a result, we still have the same coverage of events in the US and Europe – and always the same deliberate omissions. By controlling the information we have about reality, this group has been able to hide their presence and the nature of their activities from us.

Media manipulation of the events surrounding September 11, 2001 has been examined extensively. Meanwhile, 1,000 architects and engineers have officially called for an investigation into the events of 9/11 by presenting facts and evidence that prove that the collapse of the World Trade Centre towers could not have been the consequence of the impact of the planes.

But you have to convince the general public of the need to finance a war in the Middle East, to serve in the military, to receive the vaccine, to pay taxes, to let themselves be robbed and killed and all this without complaint, and you can only persuade the general

public to do all these things by deceiving them on a gigantic scale into believing they are threatened by terrorists. swine flu, global warming and so on.

The role of the mainstream media in carrying out the swine flu vaccination scam cannot be underestimated. Thomas Glocer, CEO of Reuters, sits on the board of Merck and James Murdoch, senior executive of News Corps, sits on the board of directors of GSK. The media has systematically exaggerated the dangers of the swine flu virus by downplaying the dangers of the vaccine. The media also creates the impression that there is a consensus when there is no consensus, for example, the consensus that vaccines are necessary.

The mass media suggests to us that we are in control, that we control our governments through elections and various other mechanisms. The reality is very different. Our national governments are entirely under the control of an international organized crime network that controls nearly every major party in the United States and Europe, right and left, just as they fund both sides of most wars.

Whether it is Bush or Obama, Thatcher or Blair, who is in power, the policies are the same and they favour the banks and energy conglomerates.

The media has always been recognized as a tool for spreading propaganda and directing people. There is a vast literature on the use of the media as an instrument to govern the masses. This is a central theme of George Orwell's 1984 novel. Orwell examines how the role of the media can be used to intimidate people and shape people's attitudes to accept permanent war, poverty, and surveillance.

The emergence of independent media has created an opportunity for us to release of this matrix of illusion, this invented reality that hides from us the evil nature of the people in charge of our

governments and who have used the great power they have from their positions at the top of the hierarchies to shape the ground in which we evolve, reduce the prices of our action and limit the path of our reflection, so that we go where they want us to go.

New communication and information technologies have helped people recognize the extent of corruption that has gripped national and international governments.

The facts about the swine flu pandemic and the vaccine are so clear that they are enough to dispel any illusions about the WHO and pharmaceutical companies. Finding out the facts, however, is not enough, important as it is. We must now take decisive action.

The government is there to serve the people. The government must respect the Constitution and laws of a country. Governments are there to protect citizens' interests, rights and freedoms. When governments cannot fulfil this function, they must be removed from power through elections. When governments do not even want to fulfill this function, but have aligned themselves with a global "elite" determined to destroy nations and their citizens, and to rob and kill even children on a gigantic scale using concealed biological weapons, then people have to take decisive action.

If the police and judges are too corrupt to convict members of government who are responsible for the fake pandemic and mass swine flu vaccination campaign despite overwhelming evidence of their crimes, the police and judges must be charged with complicity.
